**BAC RESOLUTION DECLARING THE LOWEST CALCULATED AND RESPONSIVE  
BID (LCRB)**

APPROVED BUDGET FOR THE CONTRACT (ABC): **₱ 2,350,000.00**

**WHEREAS**, the TARLAC STATE UNIVERSITY advertised the Invitation to Bid for the project Supply and Delivery of Nursing Clinical Skills Manikin with an Approved Budget for the Contract (ABC) of ₱ 2,350,000.00 in the Philippine Government Electronic Procurement System (PhilGEPS) and in conspicuous places in Tarlac State University on January 27, 2022;

**WHEREAS**, in response to the Invitation to Bid, four (4) prospective bidders participated in the Pre-Bidding Conference held at Tarlac State University Business Center Audio Visual Room (TSU-BC AVR) and webcasted via Zoom on February 3, 2022;

**WHEREAS**, in the public bidding held at the TSU-BC AVR and webcasted via Zoom on February 15, 2022, at 2:00 P.M.:

- (a) five (5) bidders, Tower Medical Distributing Co., Inc., Scigate Technology Corp., Microgenetix, Inc., Krypton International Resources Sales & Services, Inc., and Aspen Multi-System Corp., tendered bids for the aforementioned project,
- (b) the Bids and Awards Committee (BAC), with the assistance of the Technical Working Groups (TWGs), opened and evaluated the bids of the five bidders and found the bids to be substantially complying with the eligibility, technical, and financial requirements for the project as prescribed in the Bidding Documents and were rated "passed",
- (c) the BAC, with the assistance of the TWGs, evaluated and ranked the bids of the five bidders,
- (d) the BAC resolved to declare Microgenetix, Inc., as the bidder with the Lowest Calculated Bid (LCB) with the bid price of ₱ 988,888.00, and
- (e) the BAC directed the TWGs to proceed with the post-qualification evaluation of the LCB;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on March 8, 2022:

- (a) the TWG for the Legal and Financial Aspects reported that the LCB was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,

- (b) the TWG for Technical Aspect reported that the LCB was non-responsive for failing to comply to the technical specifications,
- (c) the BAC verified the reports of the TWGs, deliberated, and unanimously agreed to declare the LCB as non-responsive and post-disqualified,
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Scigate Technology Corp., the second Lowest Calculated Bid, and
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Microgenetix, Inc.;

**WHEREAS**, in the Post-Qualification Evaluation Conference held via Zoom on April 5, 2022:

- (a) the TWG for Financial and Legal Aspects reported that the bid of Scigate Technology Corp., was responsive to the legal and financial requirements for the project as prescribed in the Bidding Documents,
- (b) the TWG for Technical Aspect reported that the bid of Scigate Technology Corp. was non-responsive for failing to comply to the technical specifications,
- (c) the BAC verified the reports, deliberated, and unanimously agreed to declare the bid of Scigate Technology Corp. as non-responsive and post-disqualified,
- (d) the BAC directed the TWGs to proceed with the post-qualification evaluation of the bid of Krypton International Resources Sales & Services, Inc., the third Lowest Calculated Bid, and
- (e) the BAC directed the Secretariat to issue the Notice of Disqualification to Scigate Technology Corp.;

**WHEREAS**, the BAC sent the Notice of Disqualification to Scigate Technology Corp. on April 28, 2022;

**WHEREAS**, Scigate Technology Corp. acknowledged the receipt of the Notice of Disqualification on April 29, 2022;

**WHEREAS**, the BAC received a Request for Reconsideration from Scigate Technology Corp. on May 2, 2022;

**WHEREAS**, the BAC immediately conveyed the Request for Reconsideration of Scigate Technology Corp. to the TWG for the Technical Aspect for their appraisal;

**WHEREAS**, in the BAC Meeting held on May 24, 2022:

- (a) the TWG for Technical Aspect reported that Scigate Technology Corp. was able to prove that they complied with the required technical specifications for the project in the arguments and explanations they presented in their Request for Reconsideration,
- (b) the TWG for Technical Aspect attested that based on the merits of the Request for Reconsideration of Scigate Technology Corp., they find the bid of Scigate Corp. as responsive to the required technical specifications for the project, and

(c) the BAC deliberated on the report and attestation of the TWG for the Technical Aspect and unanimously agreed to reverse its earlier decision declaring the bid of Scigate Technology Corp. as non-responsive to responsive;

**THEREFORE**, We, the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

(a) to declare Scigate Technology Corp., as the bidder with the Lowest Calculated and Responsive Bid (LCRB) with the bid price of ₱ 1,600,000.00 and

(b) to recommend to the President the Award of Contract for the project Supply and Delivery of Nursing Clinical Skills Manikin to Scigate Technology Corp.


